Western Irrigation Projects Economic Benefits Review -

Phase I

During the Advisory Committee's March 17th conference call, a recommendation was made to the Alliance Board of Directors to begin Phase I of the Western Irrigation Projects Economic Benefits Review. This project would be the first westwide economic review summarizing for the rest of the country what western water users have known all along - there are significant economic benefits from the federal water projects and irrigated agriculture. The Directors have unanimously accepted the Advisory Committee recommendations which include:

- Hiring Dr. Darryll Olsen to serve as the principal investigator of the project.
- Dr. Olsen will be responsible for the following tasks during Phase I:

Identify and review existing USBR - and other sources studies on project economic benefits (what is available)

Review the GAO report and specify key issues that should be responded to within the FFA report

Work with FFA Executive Director, Board and Advisory Committee to define FFA report scope-of-work, issue

coverage, and report style format; attend review/workshop meetings as required.

Identify senior reviewers for report review/participation

Prepare detailed outline of the FFA report for Phase II action, for review by FFA Executive Director/Board/Advisory Committee

* Funding for this special project (which is new and not included in the 1997 Budget) will be shared by all Alliance member states. The anticipated Phase I cost of \$9,276.25 to be apportioned according to the number of irrigated acres in the states (see attached).

There is tremendous enthusiasm for this project. Once it is complete, western water users will finally have accurate information about the economic benefits of federal water projects - to the nation, states and rural communities. This economic review will put us on the offensive on an issue that does not seem to go away - "double subsidy" attacks, corporate welfare and inaccurate information from our opponents will continue and probably escalate.

The Western Irrigation Projects Economic Benefits Review is a project developed by Alliance member states with the goal of benefiting all western water users. Alliance Directors and members of the Advisory Committee will be briefed and asked to review, comment and provide direction throughout the development of the economic review. This will be a quality project that we will all benefit from - and all must work to support. Your states' funding commitment is imperative. Phase I funding is due by May 15th. We have provided Phase II estimate costs for your states' planning purposes. Please call me if you have any questions.

Key Action Steps:

- ▶ <u>Define Effort Level</u>: The FFA Directors should establish the level of effort and funding actually desired. There are at least two major options: 1) a "targeted" Technical Memorandum or "white paper" that focuses on selected issues, referring to different irrigation projects (\$25-50k); or a full study/review evaluating in detail several projects (\$50-100k). Also, the FFA Directors should separate the review design phase (I) from the review development phase (II), a two-phase approach is recommended.
- > <u>Initiate Phase I. Select Principal Investigator:</u> The FFA Directors should select a principal investigator for the review study. The PI will be the prime contractor responsible for project development, implementation, and completion. The PI selection should be accomplished through a request for qualifications (RFQ) process.
- > <u>Secure Congressional Support and Endorsement</u>: With the PI, meet with members of the Western Water Caucus (WWC) to solicit their direct endorsement for the review and to identify their "hot button" issues.
- > <u>Define Explicit Project Scope</u>: With the PI, hold a review workshop to define explicitly the project objectives, target audience, scope of work, and "targeted" irrigation projects and issues. This action could be combined with the WWC meeting.
- > <u>Prepare Review Proposal to FFA:</u> The PI will prepare a formal review proposal/outline for the review describing scope of work, time line, co-authors and senior reviewers, and total Phase II review costs (including presentation meetings).
- > <u>Initiate Phase II. Prepare Review:</u> The FFA Directors authorize the PI to proceed with review preparation, with designated deliverable dates for draft work products and final report.
